**AMENDMENT 2
CONTRACT NO. 4217**

THIS AMENDMENT TO CONTRACT 4217 (Contract), for services to inspect, calibrate, and certify speed detection devices, is entered into and effective this August 18, 2023, by and between the City of Tallahassee (City), a Florida municipal corporation, and Williams Communications Inc. (Contractor), a Florida corporation with principal offices at 5046 Tennessee Capital Boulevard, Tallahassee, Florida, 32303, referred to herein individually as a "Party" or collectively as the "Parties."

RECITALS

WHEREAS, the Parties entered into the Contract on May 29, 2018, and have extended the Contract through May 28, 2026, copies of which are available in the City's Treasurer-Clerk's office and, by reference, are incorporated herein; and,

WHEREAS, pursuant to Section 1.1.2 of the Contract, the Parties have agreed to amend the Contract to include a change order that adds services to inspect, calibrate, and certify speed detection devices.

NOW THEREFORE, in consideration of the mutual promises contained herein, and other good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, the Parties agree to the following:

1. The above recitals are hereby incorporated into, and made a part of, this Contract.
2. Exhibit A for services to inspect, calibrate, and certify speed detection devices, attached hereto, is hereby incorporated.
3. Except as specifically amended herein, the terms and conditions of the Contract remain the same and shall continue in full force and effect.
